A RESOLUTION TO AMEND THE BUDGET FOR THE MIDDLETON DOWNTOWN COMMUNITY DEVELOPMENT DISTRICT FOR FISCAL YEAR BEGINNING OCTOBER 1, 2023 AND ENDING SEPTEMBER 30, 2024

WHEREAS, On September 15, 2023 the Middleton Downtown Community Development District and Middleton Community Development District-A entered into an interlocal agreement for maintenance of project wide improvements; and,

WHEREAS, On September 6, 2024 the Board of Supervisors approved the amended and restated interlocal governmental agreement for maintenance of project wide improvements with Middleton Community Development District-A removing the fiscal and operational responsibility for all parks within exhibit "A" from Middleton District-A and amending exhibit "A"; and,

WHEREAS, As a result of this amended agreement, the projected costs of maintenance and repair for the infrastructure and landscaping associated with the parks within exhibit "A" must be moved to the Middleton Project Wide Fund; and,

WHEREAS, the District has accepted maintenance and repair activities for additional areas within the District boundaries; and,

WHEREAS, the additional projected costs of maintenance and repair for the infrastructure and landscaping in the Middleton Project Wide Fund are \$939,713; and,

WHEREAS, the District Manager has heretofore prepared and submitted to the Board of Supervisors an Amended Budget for the District's operating budget for Fiscal Year 2024-25.
